Subject: Request of 7 February 2011 for access to documents concerning Thomas Lönngren

Further to your letter of 7 February 2011 please find attached two letters concerning the activities of Mr Thomas Lönngren from 1 January 2011 onwards. The first is from Mr Lönngren sent on 28 December 2010 (incorrectly dated 28 January 2010) and the second is signed by Mr Pat O'Mahony, chairman of the Management Board, dated 8 January 2011.

Mr Lönngren has sent a second letter providing further details, and we are refusing access to this document since it is currently under review by the Agency's Joint Committee in accordance with Article 16 of the Staff Regulations.

Concerning the reported comments published in *Pharmaceutical Executive* magazine, no specific information was given to the magazine and the same information was provided in Mr Lönngren's letter of 28 December 2010 and no objections were raised in the Agency's response of 11 January 2011.

You also raise the DIA Distinguished Career Award Mr Lönngren received in 2008. It is a recognition of a long career rather than a material award, and neither has any intrinsic value nor confers any privileges or advantages. No decision was therefore either requested or given under Article 11 of the Staff Regulations since it was considered that the award does not fall within the meaning of Staff Regulations.

If you wish to appeal against this decision, you should write to the Acting Executive Director of the Agency, Mr Andreas Pott at the address below, repeating your initial request. You have fifteen working days from receipt of this letter in which to appeal. Beyond this deadline, your initial request will be considered withdrawn.



The Acting Executive Director will inform you of the outcome of the appeal of your request within fifteen working days of receipt of your request, either by granting you access to the documents or by confirming the refusal. In the latter case, he will also inform you of any further appeal routes you may take.
